## **COVID-19 Vaccine and Monoclonal Antibodies Billing Information**

As a Medicare Advantage plan, First Choice VIP Care Plus wants to remind you that according to the Centers for Medicare & Medicaid Services (CMS) if you intend to administer either the COVID-19 vaccine or monoclonal antibodies bamlanivimab, casirivimab or imdevimab both the administration and vaccine must be billed to Original Medicare through the Medicare Administrative Contractor (MAC) for 2020 – 2021 dates of service. Please refer to the CMS COVID-19 Provider Toolkit website at <a href="https://www.cms.gov/covidvax-provider">https://www.cms.gov/covidvax-provider</a>. The toolkit will provide you information on the following:

- How health care providers can enroll in Medicare to bill for administering COVID-19 vaccines.
- The COVID-19 Vaccine Medicare coding structure.
- The Medicare reimbursement strategy for COVID-19 vaccine administration.
- How health care providers can bill correctly for administering vaccines, including roster and centralized billing.

CMS has asked us to convey to our provider network the following information\*:

- Be aware of your reporting requirements for the vaccination providers must record details of the
  vaccination into their system of record within 24 hours, and into the applicable public health system
  within 72 hours. Detailed information regarding this can be found in the Centers for Disease Control
  and Prevention (CDC) COVID-19 Vaccination Program Interim Playbook for Jurisdiction Operations
  found at <a href="https://www.cdc.gov/vaccines/covid-19/covid19-vaccination-guidance.html">https://www.cdc.gov/vaccines/covid-19/covid19-vaccination-guidance.html</a>.
- For vaccines that require multiple doses, we want to encourage providers to communicate to their patients to get both doses of the same vaccine and to schedule an appointment for the second dose immediately following the first dose.
- Medicare beneficiaries have full freedom of choice of vaccine providers, both in and out of network.
- There is no cost to your Medicare patients for them to receive COVID-19 shots.
